BAUTISTA AND THE HONORABLE MEMBERS OF THE QUEZON CITY COUNCIL, TO VICENTE C. SOTTO III, ANNA DOMINIQUE COSETENG, FRANCIS PANCRACIUS N. PANGILINAN AND MICHAEL T. DEFENSOR, WHO SERVED AS ELECTED PUBLIC OFFICIALS OF THIS CITY, IN THEIR CANDIDACY TO THE FORTHCOMING SENATORIAL ELECTION ON MAY, 2007.

Sotto III, was a former Vice Mayor and Presiding Officer of the Quezon City Council before being elected Senator for two consecutive terms; Anna Dominique Coseteng served as a member of the House of Representatives representing the City's 3rd District until her election to the Senate; Michael T. Defensor likewise started as the elected Councilor of the 3rd District before he was elected to the House of Representatives of the same district; while Francis Pancracius N. Pangilinan was also elected City Councilor of the 4th District before he became Senator;

WHEREAS, these former City government, City officials have recently filed their certificate of candidacy for the forthcoming senatorial election;


