A RESOLUTION CONVEYING THE QUEZON CITY COUNCIL'S COMMENDATION TO QUEZON CITY TREASURER DR. VICTOR B. ENDRIGA FOR HIS EXEMPLARY PERFORMANCE OF SETTING UP A MODEST BUILDING TO SERVE AS HEADQUARTERS OF THE PHILIPPINE ASSOCIATION OF LOCAL TREASURERS AND ASSESSORS (PHALTRA) FROM HIS ELECTION AS PRESIDENT OF THIS 4,000-STRONG ASSOCIATION.

WHEREAS, the promise of Quezon City Treasurer Victor V. Endriga during his quest for the presidency of the Philippine Association of Treasurers and Assessors (PHALTRA) on September 1, 2005, has materialized with the inauguration of the first ever headquarters of PHALTRA in its 74th year of existence, slated for January 5, 2007;

WHEREAS, the PHALTRA headquarters is situated on a 200 square meters property at 139 Matahimik Street, Diliman, Quezon City, donated by Star Express Placement Inc., owned and operated by the Endriga family. The four storey edifice boasts of a modern convention hall on the 2nd floor featuring the latest state-of-the art, top-of-the-line audio visual aids designed to make the year round seminar workshops to upgrade revenue-generating know-how of local treasurers and assessors, exciting if not informative experience;

WHEREAS, the 3rd and 4th floors will serve as dormitories with full service capacity to accommodate 50 male and 50 female workshop participants. The ground floor houses both executive suite and secretariat. The whole building permeates with first-class hotel ambiance that should satisfy even the most discriminating guests;

WHEREAS, it has been the vision of Dr. Endriga as president of PHALTRA, to make the dream of local revenue generators of a place where they could congregate and simultaneously hone their tax collection prowess to better serve the nation, a reality;

WHEREAS, the donation of the land on which the structure was built, was in compliance with the dying wish of their mother and the treasurer's late wife, Emma Villaruel-Endriga, who vowed to support PHALTRA ramrod in carrying out his plans and programs;

WHEREAS, bequeathing a parcel of land to PHALTRA, owned by the family, is to them a sacred duty to fulfill their father's promise as it is their privilege to participate in molding, shaping and strengthening the quality of local tax collectors with the end in view of ensuring the fiscal and financial stability of our nation;


