RESOLUTION GRANTING FINANCIAL ASSISTANCE TO THE FAMILY AND SURVIVING HEIRS OF THE LATE BARANGAY KAGAWAD ROLANDO L. FERRER OF BARANGAY TEACHER'S VILLAGE WEST, QUEZON CITY, IN THE AMOUNT OF FORTY THOUSAND PESOS (Php40,000.00), TO BE CHARGED AGAINST THE APPROPRIATION FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS UNDER THE 2007 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS OF THE CITY TREASURY.
