A RESOLUTION EXPRESSING COMMENDATION OF THE QUEZON CITY COUNCIL TO DR. ANTONIETA V. WHEREAS, the Honorable City Mayor Feliciano R. Belmonte, Jr., allocated P114 Million for the construction and repair of Health Centers and upgraded six (6) into Super Health Centers;

WHEREAS, Dr. Antonieta V. Inumerable, with a degree of Master in Public Health, upon her assumption as Officer-In-Charge of the Quezon City Health Department, introduced innovative approaches in upgrading public health services in these centers certified as Sentrong Sigla Health Centers by the Department of Health;

WHEREAS, the upgraded facilities coupled with organized procedures effectively implemented in these health centers, seventeen (17) centers had gained the recognition of the Department of Health;


WHEREAS, additional 18 improved health centers are now in the process of assessment and certification by the Department of Health before the first quarter of 2007;


NOW, THEREFORE,
