RESOLUTION NO. SP-**3751**, S-2007
(PR2007-01)

A RESOLUTION URGING QUEZON CITY MAYOR FELICIANO R. BELMONTE, JR., THIS CITY, TO EXTEND FINANCIAL ASSISTANCE TO THE DECEMBER 17, 2006 VICTIMS OF FIRE THAT BURNED THE RESIDENTIAL HOUSES OF FORTY-SIX (46) FAMILIES AT LIKOD COMMISSION ON AUDIT (COA) TRIBU AREA, COVERING THE STREETS OF KAUNLARAN, KATANGIAN, KATUPARAN AND KALAYAAN, BARANGAY BATASAN HILLS, THIS CITY, AT TWO THOUSAND PESOS (P2,000.00) PER FAMILY OWNER AND ONE THOUSAND PESOS (P1,000.00) PER FAMILY RENTER/SHARER, WHICH SHALL BE TAKEN FROM THE CALAMITY OR EMERGENCY FUND OF THE CITY GOVERNMENT OR FROM ANY AVAILABLE FUNDS THEREOF.

WHEREAS, on December 17, 2006, at around 2:00 p.m., Likod COA Tribute Area, covering the streets of Kaunlaran, Katangian, Katuparan and Kalayaan, Barangay Batasan Hills, Quezon City, was hit by fire that burned twenty-eight (28) houses whose owners are now in dire need of financial assistance most especially from the City government;


WHEREAS, due to the occurrence of such unfortunate and devastating circumstance, the residents are experiencing financial difficulties and shall therefore be provided assistance in the form of cash;

WHEREAS, under the Local Government Code, local government units are empowered to adopt measures to protect the inhabitants of the City from harmful effects of the man-made or natural calamities, and to provide relief services and assistance for victims during the aftermath of disasters or calamities, and their return to livelihood following said event.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to urge, as it does hereby urge, Quezon City Mayor Feliciano R. Belmonte, Jr., this City, to extend financial assistance to the December 17, 2006 victims of fire that burned the residential houses of Forty-Six (46) families at Likod Commission on Audit (COA) Tribu Area, covering the streets of Kawlaran, Katangian, Katuparan and Kalayaan, Barangay Batasan Hills, this City, at Two Thousand Pesos (P2,000.00) per family owner and One Thousand Pesos (P1,000.00) per family renter/sharer, which shall be taken from the Calamity or Emergency Fund of the City government or from any available funds thereof.
