A RESOLUTION SUPPORTING HOUSE BILL NO. 4883, FILED BY REPRESENTATIVE CATALINO V. FIGUEROA, ENTITLED "AN ACT CREATING THE DEPARTMENT OF YOUTH WELFARE AND DEVELOPMENT (DYWD) AND APPROPRIATING FUNDS THEREOF."

WHEREAS, House Bill No. 4883 aims to create a Department of Youth Welfare and Development (DYWD), which will assume the functions of all government agencies, bureaus and councils currently catering to the welfare and development of the youth nationwide, and such other functions as may be assigned to it by law;

WHEREAS, House Bill No. 4883 states that the Department of Youth Welfare and Development (DYWD) shall provide for the formulation of policies and in the setting of priorities and directions of all youth development programs and activities; encourage intensive and active participation of the youth in all governmental and non-governmental programs, projects and activities affecting them; develop and harness the full potential of the youth as partners in nation-building; supplement government efforts for youth promotion and development; and provide a centralized, reliable, efficient and systematic youth welfare and development office for all the youth nationwide;


WHEREAS, the proposed legislation shall have a meaningful impact on the youth sector especially those who are marginalized and those who need special protection.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to support, as it does hereby support, House Bill No. 4883, filed by Representative Catalino V. Figueroa, entitled "An Act Creating the Department Of Youth Welfare And Development (DYWD) and Appropriating Funds Therefor."
