A RESOLUTION GRANTING FINANCIAL ASSISTANCE TO THE FAMILY AND SURVIVING HEIRS OF THE LATE BARANGAY CHAIRMAN ROMY L. FERRER, A FORMER BARANGAY CHAIRMAN OF BARANGAY MALAYA, QUEZON CITY, IN THE AMOUNT OF FORTY THOUSAND PESOS (P 40,000.00), TO BE CHARGED AGAINST THE APPROPRIATIONS FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS IN THE 2007 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR, OR FROM FUNDS THAT ARE AVAILABLE IN THE CITY TREASURY.


