*A RESOLUTION GRANTING A SPECIAL PERMIT TO KALANTIAW OTB STATION (RAMON P. BUENDIA) TO OPERATE AND MAINTAIN OFF-TRACK BETTING STATION AT 167 KALANTIAW STREET, BARANGAY MASAGANA, PROJECT 4, QUEZON CITY, SUBJECT TO THE RULES AND REGULATIONS PROMULGATED BY THE GAMES AND AMUSEMENT BOARD.*

*WHEREAS, Kalantiaw OTB Station (Ramon P. Buendia), a duly registered entity, is applying for a special permit from the City Council as a requirement for the issuance of Business Permit pursuant to Resolution No. SP-3135, S-2005;*

*WHEREAS, applicant is authorized to maintain and operate an off-track betting station by the Manila Jockey Club Inc. and Philippine Racing Club, Inc;*

*WHEREAS, Kalantiaw OTB Station (Ramon P. Buendia) had complied with various requirements in securing its Business Permit.*

*NOW, THEREFORE,*


*BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to grant, as it does hereby grant, a Special Permit to Kalantiaw Off-Track Betting Station at 167 Kalantiaw Street, Barangay Masagana, Project 4, Quezon City, subject to the Rules and Regulations promulgated by the Games and Amusement Board.*

RESOLVED, FURTHER, that Kalantiaw OTB Station (Ramon P. Buendia) shall remit to the City Treasurer in lieu of all taxes, a franchise fee of three percent (3%) of the gross revenue herein granted, which shall be made payable yearly to the City Treasurer during the lifetime of this measure.


RESOLVED, FURTHERMORE, that the authority herein granted shall be for a period of two (2) years only and it may be renewed by the City Council.
