A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO PRYCE GASES, INCORPORATED FOR THE OPERATION OF AN AUTO GAS REFILLING STATION LOCATED AT CENTRAL TERMINAL, EDSA, NORTH TRIANGLE, QUEZON CITY.


WHEREAS, Pryce Gases, Incorporated has complied with the requirements for the issuance of a Special Use Permit as required by said Ordinance;
