A RESOLUTION URGING THE PRIVATE CONCESSIONAIRES: THE MAYNILAD WATER SERVICES INC. (MWSI) SERVING THE WEST HALF OF QUEZON CITY, AND THE MANILA WATER CORPORATION (MWC) SERVING THE EAST PORTION OF QUEZON CITY, IN COOPERATION AND COORDINATION WITH THE QUEZON CITY FIRE DEPARTMENT TO INSPECT AND MAINTAIN ALL EXISTING FIRE HYDRANTS IN QUEZON CITY.

WHEREAS, numerous incidents of fires in the past years have destroyed lives and properties in Quezon City;

WHEREAS, there have been reported incidents by residents of Quezon City of non-operational fire hydrants which could not be used during emergency fire situations;

WHEREAS, there is an urgent need to check all existing fire hydrants of Quezon City as they are necessary tools in firefighting activities.



(MWSI) serving the west half of Quezon City and the Manila Water Corporation (MWC) serving the east portion of Quezon City, in cooperation and coordination with the Quezon City Fire Department, to inspect and maintain all existing fire hydrants in Quezon City.
