**A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO ARLINGTON MEMORIAL CHAPELS, INC., FOR THE CONSTRUCTION AND OPERATION OF A MULTI-PURPOSE INCINERATOR/RETORT FOR CREMATION AND A MORTUARY TO BE LOCATED AT NO. 10 G. ARANETA AVENUE, QUEZON CITY.**

*WHEREAS, petitioner Arlington Memorial Chapels, Inc., thru their President, Mr. Rafael S. Jose, is a duly registered Mortuary under Philippine laws, is applying for the issuance of a Special Use Permit (SUP) for the construction and operation of a Multi-Purpose Incinerator/Retort for Cremation and Mortuary to be located at No. 10 G. Araneta Avenue, Quezon City;*

*WHEREAS, a multi-purpose incinerator/retort for cremation and a mortuary are among the uses which require a Special Use Permit upon the authorization from the Quezon City Council as provided for by Ordinance No. SP-918, S-2000, otherwise known as the Quezon City Comprehensive Zoning Ordinance of 2000, as amended;*

*WHEREAS, petitioner has complied with the requirements for the issuance of a Special Use Permit for the said purpose as required by the said Ordinance;*
