A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR FELICIANO R. BELMONTE, JR., TO FORGE A PARTNERSHIP WITH THE GREATER DON ANTONIO HEIGHTS SENIOR CITIZENS ASSOCIATION, INC. (GDAHSCAI) THROUGH THE OFFICE FOR THE SENIOR CITIZENS AFFAIRS (OSCA) IN ACCORDANCE WITH SECTIONS 8 TO 10 OF REPUBLIC ACT NO. 9257, OTHERWISE KNOWN AS THE "EXPANDED SENIORS CITIZENS ACT OF 2003" AND TO ALLOW THE FORMER TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE GREATER DON ANTONIO HEIGHTS SENIOR CITIZENS ASSOCIATION, INC., (GDAHSCAI) TO USE, MANAGE, AND ADMINISTER A PORTION OF THE OPEN SPACE EQUIVALENT TO SIXTY (60) SQUARE METERS BESIDE THE PASTORAL COUNCIL OFFICE LOCATED AT THE DON ANTONIO HEIGHTS, BARANGAY HOLY SPIRIT, QUEZON CITY, REGISTERED IN THE NAME OF QUEZON CITY, UNDER TRANSFER CERTIFICATE OF TITLE NUMBERED 213386 OF THE REGISTER OF DEEDS OF QUEZON CITY, FOR THE PURPOSE OF PUTTING UP THE HEADQUARTERS OF THE GREATER DON ANTONIO HEIGHTS SENIOR CITIZENS ASSOCIATION, INC. (GDAHSCAI).

WHEREAS, the Greater Don Antonio Heights Senior Citizens Association, Inc. (GDAHSCAI) is a non-stock, non-profit corporation duly organized and existing under and by virtue of the Laws of the Philippines, with principal office address at No. 9 Holy Spirit Drive, Don Antonio Heights, Brgy. Holy Spirit, Quezon City;

WHEREAS, the Greater Don Antonio Heights Senior Citizens Association, Inc., (GDAHSCAI) is authorized to forge a partnership with the Quezon City government by virtue of its Board Resolution No. 2 Series of 2007;

WHEREAS, the establishment of a partnership by the Quezon City government with the Greater Don Antonio Heights Senior Citizens Association, Inc., (GDAHSCAI) will afford the latter to align the implementation of its programs, projects and plans with the local government of Quezon City under Sections 8-10 of R.A. 9257;

WHEREAS, the alignment of Greater Don Antonio Heights Senior Citizens Association, Inc., (GDAHSCAI) projects, plans and programs with the Quezon City government, will redound to the greater benefit and well-being of the growing population of senior citizens in the community;


WHEREAS, in order for the Greater Don Antonio Heights Senior Citizens Association, Inc., to be fully operational and effective in the implementation of its projects, plans and programs, it has requested the Quezon City government to allow them to use, manage, and administer a portion of the open space equivalent to sixty (60) square meters beside the Pastoral Council Office located at Don Antonio Heights, Barangay Holy Spirit, Quezon City, under Transfer Certificate of Title Numbered 213386 of the Register of Deeds of Quezon City, for the purpose of building its headquarters in the said area for easy accessibility and to provide a permanent venue for the implementation of its plans, programs and projects;

WHEREAS, the Quezon City government is fully committed to provide the needed support to the senior citizens in the community through the Greater Don Antonio Heights Senior Citizens Association, Inc., (GDAHSCAI) in the implementation of its projects, plans and programs.


NOW, THEREFORE,

(GDAHSCAI).
