A RESOLUTION URGING THE HONORABLE, CITY MAYOR FELICIANO R. BELMONTE, JR., TO GRANT FINANCIAL ASSISTANCE TO THE FAMILY OF THE LATE BARANGAY KAGAWAD ANTONIO E. MANGADAP OF BARANGAY BATASAN HILLS, DISTRICT II, QUEZON CITY, IN THE AMOUNT OF FORTY THOUSAND PESOS (P40,000.00), TO BE TAKEN FROM GRANTS, SUBSIDIES AND CONTRIBUTIONS UNDER THE 2007 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS OF THE CITY TREASURY.




NOW, THEREFORE,
