**A RESOLUTION EXPRESSING SUPPORT FOR THE CELEBRATION OF UP DILIMAN MONTH ON FEBRUARY 2007 AND RECOGNIZING UP DILIMAN AS THE CENTER OF ACADEMIC EXCELLENCE IN QUEZON CITY.**

*WHEREAS, February marks the founding anniversary of UP Diliman which was officially inaugurated on February 12, 1949, with the installation of the Oblation, the UP symbol of academic freedom, at the 493-hectare campus in Quezon City;*

*WHEREAS, since its founding more than half a century ago, UP Diliman has evolved into the administrative seat and flagship university of the UP system, distinguishing itself not only as the home of diverse colleges but also several centers of research, many of which have been declared by the Commission of Higher Education as National Centers of Excellence. To date, many faculty members, students and alumni from UP Diliman have earned recognition both here and abroad for their contributions and achievements in the fields of governance, law, science and technology, arts and culture, and sports;*

*WHEREAS, Quezon City prides itself for being home to the nation's premiere state university and fully supports UP Diliman's goal of re-asserting its place among the leading universities in the Asia-Pacific region;*




