A RESOLUTION GRANTING A SPECIAL USE PERMIT TO CALTEX PHILIPPINES, INC., FOR THE RENOVATION OF AN EXISTING GASOLINE STATION LOCATED AT NO. 41 ANONAS CORNER KAMIAS ROAD, BARANGAY EAST KAMIAS, DISTRICT III, QUEZON CITY.

WHEREAS, the petitioner, Caltex Philippines, Inc., a domestic corporation duly registered under Philippine Laws, represented by its Area Marketing Support Manager, Mr. Leo Vasco G. Dagamac, is applying for the issuance of a Special Use Permit (SUP) for the renovation of its existing gasoline station located at No. 41 Anonas corner Kamias Road, Barangay East Kamias, this City, in compliance with Ordinance No. SP-918, S-2000, otherwise known as the Quezon City Comprehensive Zoning Ordinance of 2000;


WHEREAS, Caltex Philippines, Inc., has obtained a clearance for the renovation of its existing gasoline station from Barangay East Kamias, dated February 27, 2007 hereto attached is the copy of the said barangay clearance.

WHEREAS, the petitioner manifested its willingness to see to it that the renovation of the above-mentioned business establishment shall not affect public health, safety, comfort, convenience and the general welfare of the community.
