RESOLUTION GRANTING FINANCIAL ASSISTANCE TO THE FAMILY AND SURVIVING HEIRS OF THE LATE VICTORINO MENGARINE DAGANG, A PERMANENT EMPLOYEE OF THE QUEZON CITY PARKS DEVELOPMENT AND ADMINISTRATION DEPARTMENT IN THE AMOUNT OF THIRTY THOUSAND PESOS (Php30,000.00) TO BE CHARGED AGAINST THE APPROPRIATIONS FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS UNDER THE 2007 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS OF THE CITY TREASURY.

WHEREAS, a permanent employee under the Parks Development and Administration Department of the Quezon City government passed away last January 9, 2007 while on duty brought about by a vehicular accident;


WHEREAS, the late Victorino Mengarine Dagang, has faithfully and unselfishly served the Quezon City government through his effective and efficient discharged of duties and functions;

WHEREAS, the selfless dedication and exemplary services of the late Victorino Mengarine Dagang, permanent employee of the Quezon City Parks Development and Administration Department deserves appreciation by way of grant of financial assistance to alleviate the plight of his bereaved family as a result of his death and as token of gratitude from the City government.


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to grant, as it does hereby grant, financial assistance to the family and surviving heirs of the late Victorino Mengarvie Dagang, a permanent employee of the Quezon City Parks Development and Administration Department in the amount of Thirty Thousand Pesos (Php 30,000.00), to be charged against the appropriations for grants, subsidies and contributions under the 2007 Annual Budget of the Office of the City Mayor or from any available funds of the City Treasury.
