RESOLUTION NO. SP- **3784**, S-2007

A RESOLUTION GRANTING BURIAL ASSISTANCE TO THE FAMILY AND SURVIVING HEIRS OF THE LATE FORMER BARANGAY KAGAWAD MYLENE ALBAÑO OF BARANGAY PALIGSAHAN, QUEZON CITY, IN THE AMOUNT OF FORTY THOUSAND PESOS (P40,000.00), TO BE CHARGED AGAINST THE APPROPRIATIONS FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS UNDER THE 2007 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS IN THE CITY TREASURY.

WHEREAS, the late former Barangay Kagawad Mylene B. Albaño of Barangay Paligsahan, Quezon City, died last October 26, 2006;

WHEREAS, the late Honorable Mylene B. Albaño has served Barangay Paligsahan as a Barangay Kagawad from 1994 to 1997;

WHEREAS, during her term, the late former Barangay Kagawad has faithfully and selflessly served her constituents;




NOW, THEREFORE,
