A RESOLUTION GRANTING A SPECIAL PERMIT TO GLORIA C. GO (YAHLIWAY OFF TRACK BETTING STATION) TO OPERATE AND MAINTAIN OFF-TRACK BETTING STATION AT #1071-A QUIRINO HIGHWAY, BARANGAY KALIGAYAHAN, DISTRICT II, QUEZON CITY, SUBJECT TO THE RULES AND REGULATIONS PROMULGATED BY THE GAMES AND AMUSEMENT BOARD.

WHEREAS, Ms. Gloria C. Go (YAHLIWAY OTB), a duly registered entity, is applying for a special permit from the City Council as a requirement for the issuance of Business Permit pursuant to Resolution SP No. 3153, S-2005;

WHEREAS, applicant is authorized to maintain and operate an Off-Track Betting Station by the Two Race Tracks Manila Jockey Club Inc. and Philippine Racing Club, Inc.;

WHEREAS, Gloria C. Go (YAHLIWAY OTB) had complied with various requirements in securing its Business Permit.


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to grant, as it does hereby grant, a Special Permit to Ms. Gloria C. Go (YAHLIWAY OTB) to maintain and operate an Off-Track Betting Station at 1071-A Quirino Highway, District II, Quezon City, subject to the rules and regulations promulgated by the Games And Amusement Board.


RESOLVED, FURTHER, that Gloria C. Go (YAHLIWAY OTB) shall remit to the City Treasurer in lieu of taxes, a franchise fee of three percent (3%) of the gross revenue of herein grantee, which shall be made payable yearly to the City Treasurer during the lifetime of this measure.

RESOLVED, FINALLY, that the authority herein granted shall be for a period of two (2) years only and it maybe renewed by the City Council.
