A RESOLUTION GRANTING A SPECIAL PERMIT TO DEVOTA F. SO TO OPERATE AND MAINTAIN AN OFF-TRACK BETTING STATION AT NO. 11 AGUDO STREET, BARRIO SAN JOSE, QUEZON CITY, SUBJECT TO THE RULES AND REGULATIONS PROMULGATED BY THE GAMES AND AMUSEMENT BOARD.

WHEREAS, the applicant is authorized to maintain and operate an Off-Track Betting Station by the Two Race Tracks Manila Jockey Club Inc. and Philippine Racing Club, Inc.;

WHEREAS, Devota F. So had complied with various requirements in securing Business Permit.

NOW, THEREFORE,


BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to grant, as it does hereby grant, a Special Permit to Devota F. So, to maintain and operate an Off-Track Betting Station at No. 11 Agudo Street, Barrio San Jose, Quezon City, subject to the rules and regulations promulgated by the Games and Amusement Board.

RESOLVED, FURTHER, that Devota F. So shall remit to the City Treasurer, in lieu of all taxes, franchise fee of three percent (3%) of the gross revenue of herein grantee, which shall be made payable yearly to the City Treasurer during the lifetime of this measure.

RESOLVED, FURTHERMORE, that the authority herein granted shall be for a period of two (2) years only and it maybe renewed by the City Council.

RESOLVED, FINALLY, that this resolution shall take effect fifteen (15) days after its approval


