A RESOLUTION REQUESTING THE PHILIPPINE CHARITY SWEEPSTAKES OFFICE (PCSO) TO DONATE TO BARANGAY SALVACION, QUEZON CITY, A PARCEL OF LAND (LOT 15, BLOCK 103) CONTAINING AN AREA OF TWO HUNDRED FORTY SQUARE METERS (240.00 SQ. M.) REGISTERED IN THE NAME OF PHILIPPINE CHARITY SWEEPSTAKES OFFICE UNDER TRANSFER CERTIFICATE OF TITLE NUMBERED 58210 ISSUED BY THE REGISTRY OF DEEDS OF QUEZON CITY.

WHEREAS, due to budgetary constraint, Barangay Salvacion cannot afford to buy an appropriate and suitable area for the purpose;




NOW, THEREFORE,
