**RESOLUTION GRANTING FINANCIAL ASSISTANCE TO THE FAMILY AND SURVIVING HEIRS OF THE LATE NUMERIANO ARCENAL GERNALE, CONTRACTUAL EMPLOYEE OF THE QUEZON CITY PARKS DEVELOPMENT AND ADMINISTRATION DEPARTMENT IN THE AMOUNT OF THIRTY THOUSAND PESOS (Php30,000.00), TO BE CHARGED AGAINST THE APPROPRIATIONS FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS UNDER THE 2007 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS OF THE CITY TREASURY.**




