*A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO PETRON CORPORATION FOR THE CONSTRUCTION AND OPERATION OF A GASOLINE SERVICE STATION LOCATED ALONG KATIPUNAN AVENUE (WHITE PLAINS ROAD), BARANGAY ST. IGNATIUS, QUEZON CITY.*

*WHEREAS, petitioner Petron Corporation, represented by SSECM Manager, Mr. Renato Abundo, a duly registered business entity under Philippine laws, is applying for the issuance of a Special Use Permit (SUP) for the construction and operation of a gasoline service station located along Katipunan Avenue (White Plains Road), Barangay St. Ignatius, Quezon City;*

*WHEREAS, gasoline service station is among the uses which require a Special Use Permit upon authorization from the Quezon City Council, as provided in Ordinance No. SP-918, S-2000, otherwise known as the Quezon City Comprehensive Zoning Ordinance of 2000;*

*WHEREAS, Petron Corporation has complied with the requirements for the issuance of a Special Use Permit as required by the said Ordinance;*


*WHEREAS, the construction and operation of a gasoline service station will promote public welfare and for the development of economy, as well as for the increase of employment in the city.*
