A RESOLUTION GRANTING FINANCIAL ASSISTANCE IN THE AMOUNT OF FIFTY THOUSAND PESOS (P50,000.00) TO THE BEREAVED FAMILY OF THE LATE BARANGAY CAPTAIN RAFAEL JIMENEZ OF BARANGAY PAANG BUNDOK, QUEZON CITY, WHO DIED ON MARCH 4, 2007, TO BE CHARGED AGAINST THE APPROPRIATIONS FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS OF THE OFFICE OF THE CITY MAYOR UNDER THE 2007 ANNUAL BUDGET OF QUEZON CITY OR FROM ANY AVAILABLE FUNDS OF THE CITY GOVERNMENT.

WHEREAS, his dedication to public service contributed to the development of Barangay Paang Bundok and improvement of the welfare and security of his constituents;


