A RESOLUTION URGING THE HONORABLE MAYOR FELICIANO R. BELMONTE, JR., TO GRANT TO THE FAMILY OF THE LATE REGULAR BARANGAY POLICE SECURITY OFFICER (BPSO) ROGELIO ARIENDA OF BARANGAY BAESA, QUEZON CITY, FINANCIAL ASSISTANCE IN THE AMOUNT OF THIRTY THOUSAND PESOS (P30,000.00). THE FUND TO BE TAKEN FROM GRANTS, SUBSIDIES AND CONTRIBUTIONS OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS OF THE CITY TREASURY.


