**A RESOLUTION PROVIDING FINANCIAL ASSISTANCE TO THE SURVIVING HEIRS OF THE LATE HONORABLE MARCIANO D. REYES, FORMER BARANGAY KAGAWAD, BARANGAY SAN MARTIN DE PORRES, DISTRICT IV, THIS CITY, IN THE AMOUNT OF FORTY THOUSAND PESOS (P40,000.00), TO BE CHARGED FROM GRANTS, SUBSIDIES AND CONTRIBUTIONS OF THE 2007 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS IN THE CITY TREASURY.**


