RESOLUTION NO. SP-**3814**, S-2007
(PR2007-23)

RESOLUTION REITERATING THE POSITION OF THE QUEZON CITY GOVERNMENT ON THE SALE OF NGC-EAST SIDE PROPERTY AT SEVEN HUNDRED PESOS (P700.00) PER SQUARE METER CONSISTENT WITH QUEZON CITY COUNCIL RESOLUTION NO. 2457, S-2004 AND MEMORANDUM ORDER 139 OF PRESIDENT GLORIA MACAPAGAL ARROYO.

WHEREAS, Resolution No. SP-2457, S-2004, has urged Her Excellency, President Gloria Macapagal Arroyo to dispose certain portions of property in the National Government Center East Side to actual bonafide residents at P700.00 per square meter based on the approved National Government Center (NGC) East Side Housing Project Master Development Plan;

WHEREAS, Memorandum Order No. 139 of the Office of the President has directed the Housing and Urban Development Coordinating Council (HUDCC) and the National Housing Authority (NHA) to dispose the land to qualified beneficiaries of the National Government Center Eastside Development Project at P700.00 per square meter;

WHEREAS, there is a necessity to address the need to make the lots at the NGC Eastside affordable to qualified residents therein in accordance with pricing policy provided in the Urban Development and Housing Act and existing rules and regulations.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to reiterate, as it does hereby reiterate, the position of the Quezon City government on the sale of NGC-East Side Property at Seven Hundred Pesos (P700.00) per square meter consistent with Resolution No. 2457, S-2004 and Memorandum Order 139 of President Gloria Macapagal Arroyo.
