A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR FELICIANO R. BELMONTE, JR., TO EXTEND FINANCIAL ASSISTANCE TO TWENTY (20) FAMILIES AFFECTED BY THE FIRE THAT RAZED A RESIDENTIAL AREA ON FEBRUARY 16, 2007 AT NO. 6-A INTERIOR F. CASTILLO STREET, BARANGAY BAGUMBUHAY, DISTRICT III, QUEZON CITY AT TWO THOUSAND PESOS (P2,000.00) PER FAMILY OWNER AND ONE THOUSAND PESOS (P1,000.00) PER FAMILY RENTER/SHARER WHICH SHALL BE TAKEN FROM THE CALAMITY OR EMERGENCY FUNDS OF THE CITY GOVERNMENT OR FROM ANY OTHER AVAILABLE FUNDS IN THE CITY TREASURY.


WHEREAS, a fire razed the houses at the residential area of No. 6-A Interior K. Castillo Street, Barangay Bagumbuhay, District III, this City on February 16, 2007.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the Honorable Feliciano R. Belmonte, Jr., City Mayor, to extend financial assistance to twenty (20) families affected by the fire that razed a residential area on February 16, 2007, at No.6-A Interior F. Castillo Street, Barangay Bagumbuhay, District III, Quezon City, at Two Thousand Pesos (P2,000.00) per family owner and One Thousand Pesos (P1,000.00) per family renter/sharer, the fund to be taken from the calamity or emergency fund of the City government or from any available funds in the City Treasury.

RESOLVED, FURTHER, that the Social Services Development Department, in coordination with Barangay Officials of Barangay Bagumbuhay, shall authenticate the beneficiaries of this assistance.
