*WHEREAS, House Bill No. 54 otherwise known as the "National
Identification Card System Act of 2007" has been recently filed before
the House of Representatives by Honorable Rozzano Rufino Biazon
from the Congressional District of Muntinlupa;*

*WHEREAS, the said legislative measure seeks to require
persons 18 years and older to have a National ID cards, and
mandating Filipinos of legal age to provide their personal information
to the Department of Justice (DOJ), and it would likewise serve as
proof of identity which contains the following data; full name of
cardholder, address, date of birth, sex, height and weight, and
additional matters or other information necessary and required by the
Department of Justice (DOJ);*

*WHEREAS, the aforesaid House Bill is intended to ease the
efforts of our police enforcers in tracking down notorious bad
elements in our society;*


NOW, THEREFORE,


