A RESOLUTION EXPRESSING THE VEHEMENT PROTEST AND OBJECTION OF THE QUEZON CITY COUNCIL TO THE SLUR MADE ON THE PERSON OF FORMER PRESIDENT CORAZON C. AQUINO BY ABC NETWORK TELEVISION SHOWS, "THE DAILY SHOW", AND STRONGLY URGING THE DEPARTMENT OF FOREIGN AFFAIRS TO SEND AN OFFICIAL NOTE VERBALE TO THE STATE DEPARTMENT OF THE UNITED STATES OF AMERICA TO PROTEST THE SAID INSULT.

WHEREAS, the Quezon City Council vehemently protest and object to the slur made to one of the notable and prominent residents of Quezon City and former President of the Filipino people.


NOW, THEREFORE,
