A RESOLUTION REQUESTING THE HONORABLE CONGRESSWOMAN ANNIE ROSA SUSANO TO SPONSOR INTO LAW THE MEMORANDUM ORDER NO. 139 OF HER EXCELLENCY PRESIDENT GLORIA MACAPAGAL-ARROYO.

Introduced by Councilors ALLAN BUTCH T. FRANCISCO, WINSTON "Winnie" T. CASTELO, RAMON P. MEDALLA, VOLTAIRE GODOFREDO L. LIBAN III, AIKO S. MELENDEZ, JORGE B. BANAL, JR. and ANTONIO E. INTON, JR.

WHEREAS, her Excellency President Gloria Macapagal-Arroyo signed Memorandum Order No. 139 on March 13, which provides;

"Directing the Housing and Urban and Development Coordinating Council (HUDCC) and the National Housing Authority (NHA) to Dispose the land to Qualified Beneficiaries of the National Government Center Eastside Development Project at Seven Hundred Pesos (P700.00) per Square Meters and providing for the continuing implementation of the project"

WHEREAS, the continuing implementation thereof could be extended even after the expiration of term of the office of her Excellency President Gloria Macapagal-Arroyo on the year 2010, hence to ensure its enforcement, there is a compelling need to enact a law as there are still households/beneficiaries who are qualified but could not avail of the program for one reason or another;


WHEREAS, there is a necessity to address the need to make the lots at the NHC affordable to qualified residents therein in accordance with the pricing policy provided in the Urban Development and Housing Act and existing rules and regulations;

WHEREAS, this is one way to counter the prevalence of squatting in the metropolis.


