WHEREAS, Brother Eraño G. Manalo, the erstwhile Executive Minister of Iglesia Ni Cristo (Church of Christ) passed away last August 31, 2009;

WHEREAS, Brother Eraño G. Manalo has remained to be an icon of spiritual renewal and patriotic direction in an era of political chaos and economic crisis through the pristine Biblical teachings he had instilled among the church members, and which are currently being propagated throughout the nation and the world;

WHEREAS, Brother Eraño G. Manalo's mandate of overseeing the church brought with it tremendous blessings of moral restitution and social harmony and order, even as the members are enjoined as a matter of church doctrine, to lead an upright and lawful way of life;

WHEREAS, Brother Eraño G. Manalo left a legacy of genuinely looking after the general welfare of members and non-members alike forging socio-civic outreach programs like the Lingap sa Mamamayan (Aid to Humanity) where the church administration responds immediately to the needs of the citizens beset by man-made and natural calamities. This compassionate heart he had bequeathed to Brother Eduardo V. Manalo;

WHEREAS, with the passing away of Brother Eraflo G. Manalo, the mantle of leadership was passed on to Brother Eduardo V. Manalo;

WHEREAS, the first year of Brother Eduardo V. Manalo's church administration saw remarkable and noteworthy accomplishments, which among others are: Ninety eight (98) new houses of worship were inaugurated, four hundred ninety two (492) new ministers were ordained, twenty nine (29) new locales and eighteen (18) extensions were added to the church, two (2) new ecclesiastical districts (Ecclesiastical District of Western Canada and Ecclesiastical of Eastern Canada) were established, the Church's Europe Main Office was also inaugurated on the Church's 96th Anniversary.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SPECIAL SESSION ASSEMBLED, to commemorate, as it does hereby commemorate the first death anniversary of Brother Eraño G. Manalo and to concurrently congratulate Brother Eduardo V. Manalo for his first year of victorious leadership as the new Executive Minister of Iglesia Ni Cristo.
