A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO CALTEX GASOLINE AND SERVICE STATION FOR THE CONSTRUCTION AND OPERATION OF A GASOLINE STATION LOCATED ALONG NO. 3 APO STREET, CORNER QUEZON AVENUE, QUEZON CITY.

WHEREAS, Gasoline Stations are among the uses which require a Special Use Permit upon authorization from the Quezon City Council as provided in Ordinance No. SP-918, S-2000, otherwise known as the Quezon City Comprehensive Zoning Ordinance of 2000;

WHEREAS, petitioner Caltex Gasoline and Service Station, a duly registered business entity under Philippine Laws, is applying for a Special Use Permit (SUP) to be used for the construction and operation of a Gasoline Station located along No. 3 Apo Street, corner Quezon Avenue, Quezon City;

WHEREAS, the proposed Gasoline and Service Station has complied with the requirements for the issuance of a Special Use Permit as required by the Quezon City Comprehensive Zoning Ordinance;
