*WHEREAS, the proposed Gasoline Station and Service Station has complied with the requirements for the issuance of a Special Use Permit as required by the Quezon City Comprehensive Zoning Ordinance;*


*WHEREAS, the construction and operation of a Gasoline Station will provide employment and promote economic development in the city.*
