RESOLUTION NO. SP- 5027, S-2010

A RESOLUTION URGING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA TO CAUSE THE TRANSFER OF TITLES OF VARIOUS ROADS, DRAINAGE AND OPEN SPACE OF SANVILLE SUBDIVISION TO THE CITY GOVERNMENT LOCATED AT BARANGAY CULLAT, QUEZON CITY WHICH WERE PREVIOUSLY DONATED TO THE CITY GOVERNMENT IN 1965 BY MS. SONIA S. ABESAMIS, PRESIDENT OF SANVILLE INCORPORATED AND HER CO-OWNER PACITA V. DELOS SANTOS, OWNER/DEVELOPER OF SANVILLE SUBDIVISION.

WHEREAS, Sonia S. Abesamis and her co-owner Pacita V. Delos Santos married to Jose Delos Santos, are the true and lawful owners of a certain parcel of lands located at Barangay Culiat, Quezon City;

WHEREAS, said parcels of land were subdivided into a residential lots, roads and open space now known as Sanville Subdivision;

WHEREAS, in compliance with P.D. No. 957 and P.D. No. 1216, Mrs. Sonia Abesamis, and her co-owner Pacita V. Delos Santos desire to convey in favor of the Quezon City Government parcels of land consisting of seven (7) road lots, one (1) drainage and one (1) open space covered under various Transfer Certificates of Title (TCT's) of the Registry of Deeds of Quezon City and containing a total area of Thirteen Thousand Three Hundred Fifty Seven Square Meters (13,357.00 sq.m.), more or less;

Bautista to cause the transfer of titles of various roads, drainage and open space of Sanville Subdivision to the City Government located at Barangay Culiat, Quezon City which were previously donated to the City Government in 1965 by Ms. Sonia S. Abesamis, President of Sanville Incorporated and her co-owner Pacita V. Delos Santos, owner/developer of Sanville Subdivision.
