RESOLUTION NO. SP- 5052, S-2011

A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO ZEVRON PETROLEUM INCORPORATED FOR THE CONSTRUCTION AND OPERATION OF A GASOLINE STATION LOCATED AT NO. 946 AURORA BOULEVARD, BARANGAY SILANGAN, CUBAO, QUEZON CITY.

WHEREAS, petitioner Zevron Petroleum Incorporated, a duly registered business entity under Philippine laws, is applying for a Special Use Permit (SUP) to be used for the construction and operation of a Gasoline Station located at No. 946 Aurora Boulevard, Barangay Silangan, Cubao, Quezon City;

WHEREAS, the proposed Gasoline and Service Station has complied with the requirements for the issuance of Special Use Permit as required by the Quezon City Comprehensive Zoning Ordinance;

WHEREAS, the construction and operation of a Gasoline Station will provide employment and promote economic development in the City.
