A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) FOR THE IMPLEMENTATION OF THE PANTAWID PAMILYANG PILIPINO PROGRAMS (4PS) AS A POVERTY REDUCTION MEASURE OF PROVIDING CONDITIONAL CASH TRANSFER TO QUALIFIED POOR HOUSEHOLDS IN QUEZON CITY.

WHEREAS, the Pantawid Pamilyang Pilipino Program (4Ps) is a poverty reduction measure developed by the Office of the President designed to provide conditional cash transfer to extreme poor households in the country;

WHEREAS, the Department of Social Welfare and Development (DSWD) has been tasked to implement this program and to coordinate with Local Government Units to ensure effective and efficient implementation;

WHEREAS, the Quezon City has been determined as one of the sites for the further implementation of 4Ps subject to the execution of a memorandum of agreement to such effect;

WHEREAS, the Quezon City Government is willing to support the program through the provision of services to ensure compliance by beneficiaries to the conditions of the program and to oversee that the proceeds of the same are truly extended to the benefit of the qualified poor households of the city.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Honorable Herbert M. Bautista to enter into a Memorandum of Agreement with the Department of Social Welfare and Development for the implementation of the Pantawid Pamilyang Pilipino Program (4Ps) as a poverty reduction measure of providing conditional cash transfer to qualified poor households in Quezon City.

RESOLVED, FURTHER, that a copy of this resolution be forwarded to Mayor Herbert M. Bautista for his information.


