A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO PHOENIX PETROLEUM PHILIPPINES FOR THE CONSTRUCTION AND OPERATION OF A GASOLINE STATION TO BE LOCATED AT NO. 1360 NICANOR ROXAS STREET CORNER BLUMENTRITT STREET, BARANGAY SAN ISIDRO LABRADOR, QUEZON CITY.

WHEREAS, petitioner Phoenix Petroleum Philippines, a business entity duly registered under Philippine laws, is applying for a Special Use Permit (SUP) to be used for the construction and operation of a Gasoline Station located at No. 1360 Nicanor Roxas Street corner Blumentritt Street, Barangay San Isidro Labrador, Quezon City.

WHEREAS, fuel stations are among the uses which require a Special Use Permit upon authorization from the Quezon City Council as provided in Ordinance No. SP-0918, S-2000, otherwise known as the Quezon City Comprehensive Zoning Ordinance of 2000;

WHEREAS, Phoenix Petroleum Philippines has complied with the necessary requirements for the issuance of a Special Use Permit as mandated by the Quezon City Comprehensive Zoning Ordinance;


WHEREAS, the construction and operation of a Gasoline Station will provide employment and promote economic development in the City.


NOW, THEREFORE,


