WHEREAS, Samar Street located at Barangay Payatas, Quezon City is a City street;


WHEREAS, the residents thereof have been clamoring for its concreting as it was damaged due to tropical storm Ondoy;

WHEREAS, concreting the damaged road will be for permanent usage and for the convenience of the residents thereof. x


NOW, THEREFORE,
