RESOLUTION NO. SP- 5071, S-2011

A RESOLUTION STRONGLY URGING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA TO EXTEND FINANCIAL ASSISTANCE TO THE SEPTEMBER 01, 2010 VICTIMS OF FIRE THAT BURNED THE RESIDENTIAL HOUSES OF FIFTY (50) FAMILIES AT KALYE 11, SAN ROQUE II, BARANGAY BAGONG PAG-ASA, DISTRICT I, QUEZON CITY AT THREE THOUSAND PESOS (P3,000.00) PER FAMILY OWNER AND TWO THOUSAND PESOS (P2,000.00) PER FAMILY RENTER/SHARER WHICH SHALL BE TAKEN FROM THE CALAMITY OR EMERGENCY FUND OF THE CITY GOVERNMENT OR FROM ANY AVAILABLE SOURCE OF FUND THEREOF.

WHEREAS, on September 1, 2010, at Kalye 11, San Roque II, Barangay Bagong Pag-asa, a fire occurred that burned the houses of fifty (50) families, who are now in dire need of financial assistance;

WHEREAS, because of this calamity, they are experiencing difficulties resulting from the incident;


WHEREAS, Section 458 (1)(iv) of the Local Government Code of 1991 empowered the Sangguniang Panlungsod to "adopt measures to protect the inhabitants of the City from the harmful effects of manmade or natural disasters and calamities, and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and in their return to productive livelihood following said event.

Bautista, to extend financial assistance to the September 1, 2010, victims of fire that burned the houses of fifty (50) families at Kalye 11, San Roque II, Barangay Bagong Pag-Asa at Three Thousand Pesos (P3,000.00) per family owner and Two Thousand Pesos (P2,000.00) per family renter/sharer, which shall be taken from the calamity or emergency fund of the City Government or from any available source of fund thereof.
