RESOLUTION NO. SP- 5079, S-2011

A RESOLUTION EXPRESSING SUPPORT AND PROMOTING ACTIVE OBSERVANCE OF THE CELEBRATION OF WOMEN'S MONTH 2011 THIS MARCH AND INTERNATIONAL WOMEN'S DAY ON MARCH 8, 2011.

Introduced by Councilor EDEN "Candy" A. MEDINA.

WHEREAS, the UN General Assembly adopted a resolution proclaiming a United Nations Day for Women's Rights and International Peace in December 1977;

WHEREAS, Proclamation No. 224 was signed by the former President Corazon C. Aquino on March 1, 1988, "Declaring the First Week of March of every year as Women's Week and March 8, 1988, and every year thereafter as Women's Right and International Peace Day", affirming our solidarity with other countries;

WHEREAS, on April 10, 1990, Republic Act No. 6949 was signed into law by former President Corazon C. Aquino, entitled "An Act to Declare March 8, of every year as a Working Special Holiday to be known as National Women's Day";

WHEREAS, Proclamation No. 227 was signed into law by former President Corazon C. Aquino on March 17, 1988, entitled "Women's Role in History Month", to strengthen the prior proclamation by emphasizing the role of Filipino women in the development of the country throughout history;

WHEREAS, the Barangay Operations Center and Gender and Development Resource and Coordinating Council shall spearhead the activities and programs to achieve better results;

WHEREAS, it is incumbent upon the City Council to encourage and promote women's rights through different activities supporting the advocacy.
