**A RESOLUTION EARNESTLY URGING QUEZON CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO CONSTITUTE AND DESIGNATE A HOSTAGE CRISIS MANAGEMENT TEAM OR COMMITTEE WHICH SHALL BE TASKED TO DRAW UP AND PREPARE AN INTEGRATED AND COMPREHENSIVE MANAGEMENT PLAN, FOR THE OPERATION OF HOSTAGE CRISIS AND OTHER SIMILAR SITUATIONS THAT MAY TAKE PLACE WITHIN THE TERRITORIAL JURISDICTION OF QUEZON CITY AND UNDERTAKE THE PROPER IMPLEMENTATION THEREOF.**

**WHEREAS, the recent hostage crisis of the City of Manila which resulted to death and injury to several persons is a wake up call for the authorities concerned to properly coordinate their respective responsibilities in the management and operation of crisis situations to avoid possible loss of lives;**

**WHEREAS, there is a felt need for the local city government of Quezon City to draw up and prepare an integrated and comprehensive management plan of operation which shall deal with the proper operation of hostage crisis and other similar situations in Quezon City.**

**NOW, THEREFORE,**

**BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to urge, as it does hereby earnestly urge Quezon City Mayor, Honorable Herbert M. Bautista, to constitute and designate a Hostage Crisis Management Team or Committee which shall be tasked to draw up and prepare an Integrated and Comprehensive Management Plan of Operation which shall deal with hostage and other similar crisis situations that may take place in the territorial jurisdiction of Quezon City, and undertake the proper implementation thereof.**
