RESOLUTION NO. SP- 5108, S-2011

A RESOLUTION EXTENDING FINANCIAL ASSISTANCE TO THE BEREAVED FAMILY AND SURVIVING HEIRS OF THE LATE FORMER BARANGAY KAGAWAD RUBEN B. RUIZ OF BARANGAY APOLONIO SAMSON, DISTRICT II, QUEZON CITY IN THE AMOUNT OF THIRTY THOUSAND PESOS (P30,000.00), TO BE CHARGED FROM THE APPROPRIATION FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS UNDER THE 2011 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUND OF THE CITY TREASURY.

WHEREAS, former Barangay Kagawad Ruben B. Ruiz peacefully joined our Creator on February 7, 2011;

WHEREAS, the late former Barangay Kagawad Ruiz had faithfully served Barangay Apolonio Samson, District II, Quezon City, and that his dedication and valuable services had redounded not only for the benefit of the said barangay but for the people of Quezon City as well;


