RESOLUTION NO. SP- 5117, S-2011

A RESOLUTION GRANTING FINANCIAL ASSISTANCE TO THE BEREAVED FAMILY AND SURVIVING HEIRS OF THE LATE ANTONIO M. LAZARO, FORMER PUNONG BARANGAY, BARANGAY NOVALICHES PROPER, DISTRICT II, QUEZON CITY, IN THE AMOUNT OF FIFTY THOUSAND PESOS (P50,000.00), TO BE TAKEN FROM THE APPROPRIATION FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS UNDER THE 2011 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUND IN THE CITY TREASURY.

WHEREAS, Hon. Antonio M. Lazaro was elected Punong Barangay of Barangay Novaliches Proper, District II, Quezon City from 1989 to 2002, or approximately thirteen (13) years of service as Barangay Captain;

WHEREAS, he has met his untimely demise on January 16, 2011 due to cardiac arrest;

WHEREAS, his dedicated service to Barangay Novaliches Proper as Punong Barangay deserves recognition as he earned the admiration and respect of his constituents, both as public official and law-abiding citizen;

WHEREAS, the City Government, as token of gratitude for the humble service of its Barangay Officials, should convey sympathy and condolences by extending financial assistance to the bereaved family and surviving heirs of the late Punong Barangay Antonio M. Lazaro. ✕

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to grant, as it does hereby grant financial assistance to the bereaved family and surviving heirs of the late Antonio M. Lazaro, former Punong Barangay, Barangay Novaliches Proper, District II, Quezon City, in the amount of Fifty Thousand Pesos (P50,000.00), to be taken from the appropriation for Grants, Subsidies and Contributions under the 2011 Annual Budget of the Office of the City Mayor or from any available fund in the City Treasury.
