FIRE AT ABBET ROAD, BARANGAY BAGBAG, QUEZON CITY AND
PROVIDE ALL AVAILABLE CITY GOVERNMENT AID TO THEM.

WHEREAS, the grant of relief to said fire victims will give them emotional stability, thus, the urgent need to address this proposed measure.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to urge, as it does hereby urge the City Mayor, Honorable Herbert M. Bautista to immediately grant financial assistance to the One Hundred Ninety Eight (198) families who were victims of the fire at Abbey Road, Barangay Bagbag, Quezon City and provide to them all available City Government aid.

RESOLVED, FURTHER, that the necessary guidelines and procedures in the grant of relief to the fire victims in Barangay Bagbag be promulgated and implemented by the concern city government offices.
