RESOLUTION NO. SP- **5128**, S-2011

A RESOLUTION GRANTING FINANCIAL ASSISTANCE TO THE FAMILY OF THE LATE FORMER PUNONG BARANGAY ANTONIO LAZARO OF BARANGAY NOVALICHES PROPER, DISTRICT II, QUEZON CITY, IN THE AMOUNT OF FORTY THOUSAND PESOS (P40,000.00) TO BE CHARGED FROM THE APPROPRIATION FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS UNDER THE 2011 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS OF THE CITY TREASURY.
