RESOLUTION NO. SP- 5132, S-2011

A RESOLUTION GRANTING FINANCIAL ASSISTANCE TO TEN (10) FAMILIES WHO WERE VICTIMS OF A FIRE THAT OCCURRED ON DECEMBER 6, 2010 AT SITIO MENDEZ, BARANGAY BAESA, QUEZON CITY, AT TWO THOUSAND PESOS (P2,000.00) PER FAMILY OWNER AND ONE THOUSAND PESOS (P1,000.00) PER FAMILY RENTER/SHARER TO BE CHARGED AGAINST THE APPROPRIATION FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS UNDER THE 2011 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS OF THE CITY TREASURY.

WHEREAS, the City Government should extend financial assistance in order to alleviate the sad plight of said fire victims.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to grant, as it does hereby grant, financial assistance to the victims of fire that occurred on December 6, 2010 at Sitio Mendez, Barangay Baesa, Quezon City at two thousand pesos (P2,000.00) each to house owners and one thousand pesos (P1,000.00) each to renters/sharers, to be charged against the appropriations for grants, subsidies and contributions under the 2011 Annual Budget of the Office of the City Mayor or from any available funds of the City Treasury.

RESOLVED, FURTHER, that the Social Services and Development Department shall, in coordination with Barangay Baesa facilitate the granting of financial assistance to the said fire victims.
