RESOLUTION NO. SP- 5133, S-2011

A RESOLUTION GRANTING FINANCIAL ASSISTANCE TO THE VICTIMS OF FIRE THAT OCCURRED ON DECEMBER 16, 2010 AT SAMPAGUITA STREET, BARANGAY APOLONIO SAMSON, DISTRICT II, QUEZON CITY, COMPRISING OF FIFTY THREE (53) FAMILY HOMEOWNERS AT TWO THOUSAND PESOS (P2,000.00) EACH FAMILY HOMEOWNER AND ONE THOUSAND PESOS (P1,000.00) PER FAMILY RENTER/SHARER TO BE CHARGED AGAINST THE APPROPRIATION FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS UNDER THE 2011 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS OF THE CITY TREASURY.

WHEREAS, a fire which occurred on December 15, 2010 at Sampaguita Street, Barangay Apolonio Samson, District II, Quezon City, rendered some people homeless;

WHEREAS, Section 458 (1) (iv) of the local Government Code of 1991 empowers the Sangguniang Panlungsod to adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities, and to provide relief services and assistance for victims during and in the aftermath of said disaster or calamities and in their return to productive livelihood following said event.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to grant, as it does hereby grant, financial assistance to the victims of fire that occurred on December 16, 2010 at Barangay Apolonio Samson, District II, Quezon City, comprising of fifty three (53) family homeowners at two thousand pesos (P2,000.00) each family homeowner and one thousand pesos (P1,000.00) each family renter/sharer, to be charged against the appropriation for grants, subsidies and contributions under the 2011 Annual Budget of the Office of the City Mayor or from any available funds of the City Treasury.
