RESOLUTION NO. SP- 5229, S-2011

RESOLUTION GRANTING FINANCIAL ASSISTANCE TO THE BEREAVED FAMILY OF THE LATE ROGER S. ANCERO, SR., FORMER BARANGAY KAGAWAD OF BARANGAY BATASAN HILLS, QUEZON CITY, IN THE AMOUNT OF THIRTY THOUSAND PESOS (P30,000.00) CHARGEABLE AGAINST THE APPROPRIATION FOR SUBSIDIES AND DONATIONS UNDER THE 2011 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS OF THE CITY TREASURY.

WHEREAS, former Barangay Kagawad Roger S. Ancero, Sr. died on November 16, 2010 due to Cardiac Arrest;

WHEREAS, the late Kagawad Ancero, Sr. first served as Barangay Kagawad of Barangay Batasan Hills on March 28, 1989 up to May 31, 1994 and was re-elected for second term serving up to July 4, 1996. On July 5, 1996, he assumed as Acting Punong Barangay in place of then Punong Barangay Arturo Ison who was preventively suspended and on January 27, 1997 up to May 31, 1997, he was appointed regular Punong Barangay in view of the untimely demise of Punong Barangay Ison;

WHEREAS, the exemplary and dedicated public services rendered by the late Kagawad Ancero, Sr. deserve recognition by way of a financial assistance to his surviving family.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to grant, as it does hereby grant financial assistance to the bereaved family of the late Roger S. Ancero, Sr., former Barangay Kagawad of Barangay Batasan Hills, Quezon City, in the amount of thirty thousand pesos (P30,000.00) chargeable against the appropriation for Subsidies and Donations under the 2011 annual budget of the Office of the City Mayor or from any available funds of the City Treasury.
