4 RESOLUTION GRANTING FINANCIAL ASSISTANCE TO THE FAMILY OF ITIE LATE LUPONG TAGAPAMAYAPA LUDIVINA ANILAO OF BARANGAY CULLIAT, DISTRICT II, QUEZON CITY, IN THE AMOUNT OF FORTY THOUSAND PESOS (P40,000.00) TO BE CHARGED AGAINST THE APPROPRIATION FOR SUBSIDIES AND DONATIONS UNDER THE 2011 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS OF THE CITY TREASURY.
