RESOLUTION NO. SP- 5249 , S-201

A RESOLUTION EXTENDING FINANCIAL ASSISTANCE TO THE BEREAVED FAMILY AND SURVIVING HEIRS OF THE LATE BARANGAY KAGAWAD EMMANUEL E. APAOAN OF BARANGAY WEST KAMIAS, DISTRICT III, QUEZON CITY, IN THE AMOUNT OF FIFTY FIVE THOUSAND PESOS (P55,000.00) TO BE CHARGED AGAINST THE APPROPRIATION FOR SUBSIDIES AND DONATIONS UNDER THE 2011 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS OF THE CITY TREASURY.

Apaoan of Barangay West Kamias, District III, Quezon City, in the amount of fifty five thousand pesos (P55,000.00) to be charged against the appropriation for Subsidies and Donations under the 2011 Annual Budget of the Office of the City Mayor or from any available funds of the City Treasury.
